## **Article III: Officers and Duties, Section 4**

The members of the Executive Board will have one student's fall band fee and Fair Share Credits waived for fulfilling their duties. Any additional student will have fall fees and Fair Share Credits assessed at 50%

## **Proposed Amendment:**

### Article III, Section 4

The members of the Executive Board will have one student's fall band fee along with fall and spring Fair Share Credits waived for fulfilling their duties. Any additional students will have fall fees and Fair Share Credits assessed at 50%.

## Current By-Law:

## Article VII: Fees and Costs, Section 2, first paragraph

Band fees can be adjusted yearly based on prior years expenses and estimated expenses for the upcoming year. Fees for the upcoming year will be announced prior to the end of the current year to allow parents to make arrangements. Fall fees will be assessed in to payments. Payment one is 50% of the total fee and is due not later than the last day of June preceding the affected year. Payment two is 50% of the total fee and is due not later than the last day of July preceding the affected year. Additional students from the same family in band will be assessed fees at 50% of the regular rate. Spring fees are due by the end of the first nine week period in the spring semester. Failure to pay fees will result in limited student participation until fees owed are paid. Parents for whom this presents a true hardship should bring their hardship to the Band Director So that alternate arrangements can be made.

Band fees can be adjusted yearly based on prior years expenses and estimated expenses for the upcoming year. Fees for the upcoming year will be announced prior to the end of the current year to allow parents to make arrangements. Fall fees will be assessed in to payments. Payment one is 50% of the total fee and is due not later than the last day of June preceding the affected year. Payment two is 50% of the total fee and is due not later than the last day of July preceding the affected year. Additional students from the same family in band will be assessed fees at 50% of the regular rate. Spring fees plus Spring instrument rental are due by the end of January, the the end of the first three weeks. Failure to pay fees will result in limited student participation until fees owed are paid. Parents for whom this presents a true hardship should bring their hardship to the Band Director so that alternate arrangements can be made.
